Our mission supports our all-Cambodian staff in empowering families of rural villages to identify and address their highest needs to achieve sustainability. Programs implement wells and safe water systems, latrines, self-help groups to build economic opportunities through pass-on animal husbandry and improved agricultural practices that improve family food security and cash crops. Healthcare training for families and education for preschoolers through 12th grade and often university strengthen skills & self-reliance for youth

In 2017 our Community Development staff worked side-by-side with Village Development Committees & self-help groups to organize and implement trainings that deliver the following self-sustaining and empowering outcomes:  
The following water sanitation projects are benefitting 2,861 people from 414 family households:  
42 biosand filters, 192 latrines, 13 water wells, 10 community ponds and 22 rooftop rainwater harvest tanks.  
The following agricultural projects are benefitting 497 families:  
11 home gardening trainings and 11 compost trainings, vegetable seeds for 50 Families, 250 chickens, 9 cows, agricultural tools and materials for 50 families, 9 trainings in animal raising for 94 families, 7 pass-on cows and 40 pass-on chickens and exchange visits for 27 people from different Community Development Committees.  
The following income generation projects are benefitting 437 people from 93 families:  
6 Self-Help Group (SHG) trainings on Financial Management in 2 villages, 10 SHG trainings on Group Forming in 6 villages, 6 SHG trainings on Bookkeeping, 1 Capacity Building training on Basic Management and Problem Solving, 5 SHG meetings to discuss challenges and solutions in Savings Programs.

In 2017 by participating in our Education Programs, over 90% of our rural students passed their government school state exams and advanced to the next grade on their way to high school graduation. Programs in our three main grade schools benefitted 563 students through enrichment classes in English, Math, Khmer Language, Library / Reading Clubs, Computer & Research Classes, Tutoring in Mathematics & Sciences (Biology, Physics, Chemistry) and Khmer Literature and traditional Cambodian dancing classes. 83 older students participated in Youth Club service and leadership activities, including hosting school events & delivering training and awareness workshops for community families and remote schools in Hygiene & Sanitation, Environment, Child Safety, Enrollment Campaigns to encourage families to enroll their children in state schools. Our teachers attended professional development courses. In 2017, 90 students continued their studies in Cambodian university degree programs in fields from IT to Agriculture to Engineering. Through special funding, we oversaw quality supplemental education for 1,549 students in 6 more schools, including a meal program! Our community outreach classes benefitted 158 children in 7 remote preschools and 186 students in special English Tutor classes. Support for our students' success also included 435 sets of school supplies, 30 bikes to help them reach school, 165 school uniforms, and a cultural field trip for 10 students to tour Angkor Wat. A dormitory supported 24 female students who lived far away from school.

In 2017 our Healthcare Programs continued to provide community families and children with training in basic healthcare and hygiene practices, including washing hands and brushing teeth and identification of chronic, acute and contagious diseases like HIV Aids, malaria and water-borne illnesses that result in severe, life threatening infant diarrhea. The Food Supplement Program (FSP) provided 158 preschool aged children (from 3 to 5 years old) with daily nutritious supplemental meals: a hot porridge (with carrots, rice, fish oil, eggs, leafy greens and garlic) made by the village community mothers and overseen by our Healthcare staff and village teachers. These meals promote cognitive development and measurable vitality and improved health in the young children. Community training workshops guided families in best sanitation practices, safe waste management and air & soil quality control. Training in emergency first aid and supply kits empowered community groups to care for each other. Special funding assisted 30 grade school students with emergency food as well as other community children with medical needs and doctor appointments, evaluations and treatments. Our sewing club produced Days for Girls Kits to assist female students with sustainable products to empower them to attend school classes and to stay healthy during their menstrual periods. Workshops also informed young women about their fertility cycles and older women about their own health and sanitation needs.

While onsite during annual visit after 2017 data were entered, Mastin conducted internal audit of original financial materials by using statistical sampling methods from generally accepted accounting standards and determined that all 2017 data accurately reflected original invoices. The Finance Team maintains responsible cash handling procedures and tracking and reporting of activity, especially for donors of grants and special fund projects. Email correspondence and calls among the Board of Directors, Committees and onsite Executive and Project Management Teams provide overview and evaluation of project and program outcomes. Teams collaborate on criteria to evaluate and measure outcomes and the steps to improve program effectiveness. Significant annual onsite visits from multiple Volunteer Directors ensure clear communication and offer hands-on observations and measurable updates on projects and programs. Annually whole staff meetings address the updates of key policies, including clarification of Code of Ethics and Conflict of Interest. In the event of any questions, onsite the Executive Director contacts the Directors for guidance and clear steps in resolving complications.
