Our mission is to empower rural Cambodian villages in becoming self-sustaining communities that coordinate their own development groups and Self-Help Groups to implement lasting programs that address their highest needs. Programs include wells and safe water, sanitation, Bio-Sand Filters (BSF), Rooftop Rainwater Harvest tanks (RRH), Gardens, Agricultural and (Continued on Schedule O, Statement 1)

Working side-by-side with beneficiary families, our teams train and empower communities to rebuild and maintain their quality of life. Access to year-round Safe Water and Sanitation Hygiene (WASH) continues to be a cornerstone of our village sustainability programs. Water supports gardens that build food security. Water supports agriculture, livestock and cash crops that lead to economic growth. Household filtered water (BSF) and food provide children (the family water carriers) with time and health to attend school to grow their futures. In 2020 Community Development Program Accomplishments and Beneficiaries included 24 Animal Pass-On Cows to benefit 24 families with 144 people with farm labor and economic opportunities, 19 Community Ponds to provide 163 families with 581 people with irrigation for raised bed gardens, fish farming, high protein and income; 9 Deep Wells to benefit 76 families with 355 people with year-round water for drinking and daily use; 130 Latrines to benefit 507 people with improved sanitation and hygiene; 47 RRH tanks to benefit 257 people by capturing rainwater in large concrete tanks, sealed to prevent contamination; 72 BioSand Filters (BSF) to benefit 322 people with home systems to reduce water-borne diseases and to improve health and productivity; 791 gardens to increase nutrition.

4b (Code:) (Expenses \$ 249,217 including grants of \$ 0) (Revenue \$ 0)

In 2020 our Education Program creatively adapted our in-classroom instruction methods for distance learning during Covid-19. Through online classes and activity hand-outs, our teachers and students did a wonderful job of staying engaged in their studies. The two main goals of our program are to provide Supplemental and Enrichment Education for the children in participating villages. Supplemental instruction strengthens our rural students' readiness to advance to the next grades in their state schools. Courses include English, Khmer Language, Math, Computers, Research and Library time. Special tutoring in advanced Sciences and Math assists older students in preparing for their 12th grade state exams. Enrichment activities include Youth Club and Student Councils that develop management and leadership skills through their self-directed community service projects, Traditional Dance Classes and Study Trip to Sim Reap build cultural connections. In all, 2,598 students from preschool through graduation benefitted from our school programs. During 2020, 7 preschool classes were temporarily interrupted for Covid-19 safety. We built 3 community schools with hand-washing stations to benefit all children in surrounding villages. Also forty-one new University students joined our existing scholars in staying active in their studies through online classes. To date 379 scholarships have helped these young people in growing their abilities to contribute to their country's emerging recovery.

4c (Code:) (Expenses \$ 40,353 including grants of \$ 0) (Revenue \$ 0)

In 2020 we added Mask Making and Covid-19 Safety Workshops to our HEALTHCARE PROGRAM. Extensive trainings supported health, hygiene and handwashing practices and supplies for 142 students and 6 teachers. Covid-19 workshop and masks prepared village community leaders in 5 villages to guide their communities through the dangers of the virus. All of our teachers and students, along with their families, received masks and safety training. In all, we made and provided over 4,500 masks. Our Preschool Nutrition Food Supplement Program provided 136 children in 5 preschools with hot meals of carrots, greens, fish, rice, egg, oil and spices. Daily hot meals encourage children to attend school where they can grow their cognitive and social development. During Covid-19 safety precautions, the Cambodian government required children to stay home for safe learning. Our Days for Girls Program led trainings in menstrual health and hygiene to benefit over 400 students in 6 secondary schools. We also provided supply kits to assist the young women in managing their monthly cycles, staying active in school and helping them to save money. Emergency funds assisted three students with operations and extensive follow-up care. Additional funds supported dormitory students with food and supplies. Several children were assisted with dental care.

Form 990, Part III, Line 3 - By March 2020, our Education and Community Development Programs faced obstacles when the Cambodian government suspended in-classroom instruction and village project implementation to prevent the spread of Covid-19. Our teachers quickly adapted to distance learning methods, including hand-outs and online instruction. Children from families with no internet access or devices needed special support from neighbors and our teachers to keep up. Village Communities also suffered loss of income opportunities and our trainings that help to introduce installations of projects like water wells. Activities resumed later in 2020 before the next virus spike in 2021.

Form 990, Part VI, Section B, Line 11b - Volunteer Treasurer Susan Mastin provides a copy of Form 990 with Support Schedules and workpapers for full review by Volunteer Directors Kevin Conlin and Richard Allen, veteran accounting professionals and onsite volunteers. Prior to the completion of Form 990, Mastin clarifies all revenue and expense transactions with the onsite Cambodian Finance Team and conducts an internal audit, including reconciliations of all grant and special projects that are managed in designated bank accounts. Data are reconciled with QuickBooks accounting files, maintained and shared by Mastin and the onsite Finance Team. In 2020, due to travel restrictions from Covid-19, Mastin introduced the random number formula to the onsite Executive Team who oversaw the hands-on audit of the original documents selected by the random audit formula. The Executive Team did a fantastic job of tracking their review of each of the 91 documents generated from the random audit list. In addition, they reviewed and made suggestions to improve our organization's Cash Handling Procedures and Policies. This unexpected challenge of 2020 became an opportunity to empower our team. Directors are in daily email connections with onsite teams to provide encouragement in problem-solving and guiding the organization forward. Annual staff meetings and retreats focus on team-building and review of policies, including Conflict of Interest, Code of Ethics and "Sacred Trust of Funds" as identified by Rotary International and individual Rotary Clubs who fund special grants and development projects.

Form 990, Part VI, Section B, Line 12c - Volunteer Director Treasurer Mastin annually provides international Directors with a copy of the organization's Conflict of Interest Policy. All are required to confirm that they received, reviewed and indeed comply with the COI policy. Should there be any questions, they are instructed to communicate with the organization's officers. In Cambodia annual staff meetings include a review of the written Conflict of Interest Policy and Code of Ethics Policies. The COI document includes examples of possible COI to assist the staff in fully understanding the policy.

Form 990, Part VI, Section C, Line 19 - In 2020 Sustainable Cambodia's website provided access to Form990 Tax Returns, Annual Report and Program Guides to share with organizations doing similar work as well as to assist onsite volunteers in preparing form their upcoming life in rural Cambodia. Upon request, all of these documents may also be provided by postal mail or email. One exception is that Schedule B is not shared with the public.

Form 990, Part XI, Line 5 - The net unrealized gains (losses) on investment resulted in of a total loss of \$15,596 from a combination of three adjustments to value. The first adjustment of a loss of \$15,000 is for the estimated value at yearend for donated XHALE stock. The second adjustment of a loss of \$516 is for the actual yearend value of donated EXXON Mobil Corp stock per Merrill Lynch investment report. The third adjustment of a loss of \$80 is for a net unrealized loss from 2019.

Form 990, Part XI, Line 8 - The prior year adjustment of \$379 is the reclassification of a \$300 donation and expenses of \$79.

Form 990, Part XI, Line 9 - As an organization, we track "Rotary Journey to Cambodia" visitors' trip revenue and expenses as "pass-through" when specific activities are only related to the visitors' in-country lodging, meals, transportation and planned tours with Cambodian temples and palaces. These activities are "pass-through" because they are not related to our actual program activities in

Education, Community Development and Healthcare. In accrual reporting, the majority of pass-through revenues are received from the participating visitors during the months of November and December of the year that precedes the actual trip activities and related pass-through expenses. In 2020, the actual pass-through expenses exceed the pass-through revenues by \$37,371. Due to Covid-19 travel precautions, there was no Rotary Journey to Cambodia trip and no pass-through revenues received in November and December. In years when the trip pass-through revenues exceed the pass-through expenses, participating Rotarians all agree to make those remaining funds available as general funds to support the programs. When the remaining funds are indeed available, they are reclassified from Rotary "pass-through revenue" to "general program revenue" donations. Everyone is hopeful that the years ahead in 2020 and 2021 will bring us all back together in Cambodia.
